



THE DEADLY REVOLVER

Two Brothers, Thomas and John Bailey Dangerously Shot Sunday Evening at Bullock Creek

Midland Republican, July 2, 1891 - Sunday evening about the time church services were closing, Mr. J. Erway of Bullock Creek, three or four miles south from Midland in Midland township drove rapidly into town for a physician and bringing the startling news that Thomas and John Bailey, brothers had been shot by a neighbor, Ed. Ostrander.

Dr. McCallum and soon after Dr. Towsley, hastened to the scene. The two brothers had been removed to the home of their uncle, Mr. Ed. Bailey, the shooting having occurred almost in front of his house. It was found that Thomas. about twenty-five years of age and having a wife and two children had received a bullet in the left groin, which had lodged probably in the pelvic cavity. John his brother, about 21 years old, was apparently more dangerously hurt. A bullet from the same revolver, caliber 38, had entered his left breast about an inch below the nipple and an inch to the left of it. It had passed through and lodged just under the skin at the left of the spine at a point about five inches lower then the entrance. Both men were made as comfortable as possible, and it was believed that there were good chances for the recovery of both.

Soon after the shooting, Mr. Ostrander accompanied by Mr. Ackerman came to Midland and gave himself up to the sheriff. He was placed in jail and on Monday was arraigned before Justice Fairchild and examination set for the 13th

of July. Bail was fixed at \$1000 and was readily furnished.

The affair is a most unfortunate and sad one. Mr. Ostrander is a young man and has a wife and two children. He and the Bailey boys have been very good friends until recently. Events earlier in the day had a bearing upon and lead up to the terrible occurrence of the evening. It appears according to reports, that a company of from eight to twelve, the Baileys among them, had met in the forenoon in a grove on Rockwell's land (see diagram) where they had one or two kegs of beer and indulged in a disgraceful carousal on what should have been a day of quiet. Mr. Ostrander, who works the farm of his mother, Mrs. Jennings, was at Homer Rumrill's, his wife being with him. One report is that some of the beer was sent to Rumrill's.

Some time before, in March, the house of Thomas Bailey had burned, and it is said that the insurance adjuster made some inquiries of Ostrander about the property, and that there was ill feeling growing out of this. At any rate, as reported, the carousers went to Rumrill's and demanded of Ostrander to come out and fight, a great deal of noise being made and language not adapted to Sunday used. Later in the day, Ostrander and wife started for home, Mrs. Jenning's house, when they were followed and attacked, clubs were thrown at them, and it is said he was told by one of the Baileys he would be killed within two days. Clubs (continued on Page 2)

were thrown at the house after it was reached. Later in the day, Ostrander was at Rumrill's again, and it is understood that the revolver was loaned him there, the feeling being that his life was in danger. He and his wife went to the home of J. Willard his brother-in-law, on the street south beyond the school House. They were returning when the disastrous meeting at first recorded, occurred. Reports of this meeting vary widely. One account is that the Baileys advanced and assaulted both Ostrander and his wife, that he warned them he would shoot, that they said his old revolver wasn't loaded. There is a ditch on each side of the wagon track and it is stated that Ostrander was in one of these when he finally fired. Another account is that Ostrander was the first to speak, the Baileys being several feet from him, one on each side the track, that he told them to let him alone or he would shoot, and that he shot immediately, they being 10 or 12 feet away, first at Thomas, then turned, and instantly fired at John. Justice Erway came up about this time, and the sisters of the Bailey's and other friends at Ed. Baileys came out and the wounded men were taken to the house. It is not the province of the Republican to try the case. The testimony must be sifted in the court. We deeply regret the mournful affair, and it is probably safe to say that had it not been for strong drink, it would not have occurred. It is asserted that a keg of beer was bought in Midland Sunday morning and taken out there. Some of those engaged in the celebration broke into the vacant Vincent home, where it is said a stove was smashed and other mischief done, that

The diagonal line represents the path through the bushes along which Ostrander and wife were reported to have been followed when they left Rumrill's

July 6, 1891 - The Baileys, victims of the shooting affair, appear to be getting along quite comfortably. They were moved yesterday, on stretchers to their father's home. In the diagram given last week there were two points marked "J". That at the corner north from Bailey's and east of Rumrill's is Mrs. Jennings's home where Ed. Ostrander, her son lives. John Bailey's place is the "J" west from the school house, half a mile south of Mrs. Jennings's.

July 16, 1891 - The Bailey boys both appear to be getting along quite well; they do not have any unfavorable symptoms, have little if any

fever, and it appears that they may both recover from the effects of their wounds.

July 16, 1891 · Examination of Ed. Ostrander in the Bailey shooting case occupied Monday and Tuesday in Fairchild's court and was adjourned to the 27th. Witnesses are not all able to be present. No evidence yet taken for the defense.

July 30, 1891 - The case of the People vs. Ostrander was called Monday. After two days work by the defence the case was adjourned until this morning. Both Tom and John Bailey were able to be in court.

August 6, 1891 - John Bailey is around town and gaining strength nicely. It is cause for congratulation to all parties that both brothers are recovering so rapidly from the effects of the shots received in the unfortunate affair which culminated so seriously. We hope nothing of the kind may again disturb the peace of any community in this county.

August 20, 1891 - The examination of E. Ostrander in relation to the shooting of the Bailey boys was ended last week, and Mr. Ostrander was held for trial in the Circuit Court, bail being fixed at \$500.

Sept. 3, 1891 - Circuit Court. Four criminal cases were added to the Calendar for the August term of circuit court after the publication of last week, viz: The people vs. Coon Stewart, bastardy; Albert Fuller, larceny; Eddie Ostrander, assault with intent to kill; ...

October 8, 1891 - Circuit Court. People vs. Albert Fuller, larceny; plead guilty to simple larceny and was remanded to await sentence.

People vs. Philip Flock, embezzlement; continued.

People vs. Ostrander, assault; on trial.

October 11, 1891 - Circuit Court. The September term of circuit court having been adjourned to next Monday, business will open on that day with jury in attendance and sixteen cases on the calendar, of which four are in the criminal list, viz: 1. The People vs. Walter Scott charged with larceny; 2. Albert Fuller, same charge; 3. Philip Flock, embezzlement; 4. Eddie Ostrander, assault with intent to murder. Wm. D. Gordon for

the defense in the first, second and fourth. Prosecuting Attorney Post for the People in all.

ASSAULT AND BATTERY

Is what the Jury Find Ostrander Guilty of, After a Stubborn Six Days Contest.

Earnest Work By the Attorneys. <<<<O>>>>

Over Three Hours Occupied in Finding This Peculiar Verdict of Guilty and Not Guilty.

October 15, 1891 - One of the most closely contested trials ever had in this county ended Tuesday night at 8 o'clock, the jury in the case of Eddie Ostrander charged with assault with intent to murder bringing in a verdict of "guilty of assault and battery," thus practically acquitting Mr. Ostrander of the charge of assault with intent to murder, or intent to do great bodily harm less than murder. The case for the people was ably conducted by Prosecuting Attorney F.L. Post and the defendant's interests were keenly cared for by Atty. W.D. Gordon. The taking of testimony was completed Monday. Tuesday was occupied by the exhaustive pleas of attorneys.

The theory of the prosecution was that Ostrander having coolly armed himself after the disturbance earlier in the day, had it in his mind to do violence to the Bailey boys if opportunity offered and that he rather sought the opportunity; while the defense claimed that he put the revolver in his pocket as a precaution because of threats of violence against him and that in walking down the street he had no reason to expect that he would come in contact with the Baileys and that he was attacked upon the public highway when in peaceful company with his wife, that because the threats before made and the manner of his antagonists he had reason to be and was in such great fear of violence that he was justified in his action, for which in the nature of the case there was not time for deliberation.

The testimony was very conflicting, especially with reference to the positions of the parties when the shooting was done and the first act of aggression at the time. It was also conflicting concerning the previous events of the day, but there is no question from all the evidence that beer had its share in the proceedings notwithstanding it was Sunday.

Throughout the trial there were many listeners, a large representation naturally being there from the vicinity of the unfortunate and disgraceful occurrences of June 28. Many ladies were among the witnesses, and these with their children and friends were necessarily at the court house. There has been no trial here in a long time which has aroused so great a degree of interest.

THE JUDGE'S CHARGE.

Judge Hart in his charge to the jury advised them that they might take into account the condition of Ostrander's mind, whether he apprehended great danger. Murder is an unlawful killing done with malice aforethought. They must consider whether had either of the wounded men died, Mr. Ostrander would have been guilty of murder, malice includes anger, hatred, revenge and other unlawful and unjustifiable motives. They must judge from the testimony whether malice existed. There is a presumption that a man intends to do what his acts are naturally calculated to accomplish. Either of these verdicts may be rendered: 1. A conviction making an assault with intent to commit the crime of murder. 2. Assault with intent to do great bodily harm less than murder. 3. Assault and battery alone. The second verdict would mean they find beyond reasonable doubt the shots were fired without right and with the intention to do harm more than a slight bruise or injury - something of a permanent nature. If they do not convict as in No. 1 or No. 2 they must consider No. 3. "Mr. Ostrander admits inflicting the wounds and these wounds will amount to an assault and battery unless you shall find from the testimony Mr. Ostrander was justifiable in doing what he did as being in self defense." "The law permits any man to defend himself and family from the assaults of another." One need not always wait till he is struck before striking if there are such demonstrations, motions, etc., as reasonably lead him to think he will be assaulted. But it must appear that his act is in some proportion to the fierceness of the attack. One is justified even in taking life if it appears to him that his life is in danger, or he is in danger of great bodily harm of serious and permanent nature. Nor can he be expected to act with that degree of coolness and judgement that one may exercise while listening to the testimony.

"If you find from the testimony that the defendant was acting in defense of himself and his wife and only did what he did in affording himself that protection which under the excitement, haste, and confusion of the moment seemed

to him reasonably necessary to protect his life, or from a permanent injury to his person, he should be acquitted.

"Each one of you must be satisfied beyond a reasonable doubt of the defendant's guilt."

The burden of proof is on the people to establish the acts done and the intent. The jury is also to determine what witnesses in their judgement tell the truth, the same rule applying to the testimony of the defendant.

The jury went into their room at 4:45 by the court house clock and at 8 returned with their verdict as above stated. Court immediately adjourned to Wednesday morning when upon motion of Mr. Gordon 40 days were granted in which to make motion for a new trial or in arrest of judgement or to settle a bill of exceptions.

October 15, 1891 - CIRCUIT COURT. The circuit court has been almost entirely occupied with the Ostrander case. Arguments were heard Monday in the Jo Drain injunction suit. Decision reserved. Wednesday morning Albert Fuller of Gratiot County who pleaded guilty of larceny of a coat valued at \$15 was released with sentence suspended, it appearing that he had already been in jail 120 days. Judge Hart talked very kindly to the young man who promised to do right hereafter. After disposing of the Ostrander matter, court adjourned to Monday next at o'clock.

Read the synopsis in this paper of Judge Hart's charge in the Ostrander case (the sentences in quotations are his exact words) and then say if Ostrander was not guilty of intent to do great bodily harm, how he could under the charge be guilty of assault and battery. By the verdict of assault and battery the jury say he did not act justifiably in self defense. Having said that, how can they reasonably say he did not mean to do great bodily harm? After deciding against the first and second possible verdicts, is not the only reasonable verdict one of "not guilty?" Was the verdict, as is alleged, a compromise between 3 and 4? Is it not as near to saying "guilty and not guilty" as is possible?

February 18, 1892 - CIRCUIT COURT. The most important business done in circuit court last week was the disposition of the case of Eddie Ostrander who was convicted of assault and battery in September term of court upon trial for intent to commit murder - the celebrated Ostrander-Bailey case. It will be remembered that forty days were allowed for the defendant to settle a

bill of exceptions or move for a new trial. A motion was made Saturday by W.D. Gordon, Mr. Ostrander's attorney, for arrest of judgment and discharge of the prisoner, and he referred to a recent decision of the supreme court of Michigan in support of his motion, the decision in a similar case being to the effect that under the information the defendant could not be convicted of assault and battery. He might have been convicted simply of assault, or of assault with intent to do great bodily harm, but assault and battery was not covered by the information. Upon careful consideration of the bearing of the decision upon the case in hand, the motion was granted and Mr. Ostrander was discharged. That ends the matter. χοχοχοχ χοχοχοχ οσοσο χοχοχοχ χοχοχοχ

For Christmas day it was a quiet, almost gloomy place, The Stag Hotel, as one wandered through the main halfway, into the office and then up the flight of stairs and through the long rows of double decked beds stood silent guard with the individual steel lockers.

The Stag Hotel is for Dow Chemical plant employees, most of whom are now a long way from their families or else have not any home at all. Is a source of much comfort to many such men. Its capacity is 222 men including the annex and more improvements are being added all the time. Only 50 remained here for Christmas.

As the men filed out of the lobby and entered the dining room you could see the change that came over them as they saw the surprise which had been prepared.

The first thing that greeted them as they entered the door was a big Merry Christmas sign which was hung just inside and then there were decorations hung around the wall in fine style.

There were two tables each decorated with a nice little Christmas tree and trimmings. Many colored lights were used and the feeling of gloom

promptly left the place, and it was indeed a real Christmas.

And talk about a Christmas dinner! That was sure one, and the menu would make any man sit up and take notice. Here are some of the things that they had: Roast veal and oyster dressing, fricassee chicken, mashed potatoes, bread and butter, cranberry sauce, orange lamange, banana nut salad, red raspberry jelly, cookies and coffee.

Mr. Johnson manager of the Stag Hotel, and wife, worked until eleven o'clock decorating and preparing for the Christmas dinner.

Mr. and Mrs. Johnson have been getting nice big Christmas dinners and making others happy in this way in various eating places for the 19 years of their married life. It is now to them just like getting dinner for a family of 50 full grown children.

Though there was no hanging of stockings, each man was delightfully remembered by the manager and his wife and it is sure that the thoughts of this Christmas will be appreciated by the men and not soon forgotten.

PRESIDENT'S MESSAGE

If you have not been to the Clarke Historical Library on the fourth floor of the main Library building at Central Michigan University, you are missing an excellent opportunity to carry out some good genealogical research. Our Speaker at the October meeting was Evelyn Glazier, the reference librarian at Clarke. She reviewed for us the many materials in their collection which are useful to genealogists. The collection specializes in Michigan materials, such as all Michigan censuses on microfilm through 1920, with indexes for 1880 through 1920. It includes a very good collection of Michigan newspapers on microfilm (primarily the smaller towns and cities), and all the Michigan regimental histories of the Civil War. But in addition to Michigan materials, it has an outstanding collection on microfilm of many county histories from states east of the Mississippi River. Call the Clark Library for verification of hours of service at (517) 774-3352. I have personally used the library on many occaisions and have found it helpful.

Although not well advertised, the genealogical collection at the Grace A. Dow Library is available for your use. Temporarily the collection is located in what is currently called the "Maga-

zine Room," but at the conclusion of the construction project this room will become the Michigan History and Genealogy Room. The room will be nicely carpeted with tables and microfilm reading and copying machines. Our geneaology society will assist in helping to furnish the room more completely.

Our NARA Gift Fund collection has reached the sum of \$13.00. This fund is for the purpose of microfilming documents useful to genealogists at the National Archives. These documents might not otherwise be filmed due to the lack of money for that purpose. We are joining with genealogical societies across the United States to request (purely voluntary) donations for \$1.00 per year per member. The jar labeled "NARA Gift Fund" will be obvious at our meetings.

MIDLAND COUNTY DEEDS

The Midland Genealogical Society has been given a box of several hundred ORIGINAL legal papers, mostly deeds, but also a few wills or mortgages. The deeds are to land tranactions in the county or by county residents. The time period covered is from 1857 to the 1930's. A number are completely hand written and some are original land grants.
